Europe is facing significant healthcare challenges due to an ageing population, increased prevalence of chronic disease and multi-morbidities.

In the past, industry, academia, healthcare professionals, regulators, and patient organisations have largely worked in silos. In practice, many decisions about patients' care, medical research, health information and service design were taken without meaningful patient engagement.

But this is starting to change. The value of collaboration with patients and patient organisations across the lifecycle of medicine is being increasingly recognized.

There are several initiatives at European level, which aim to identify the needs around patient engagement and strive to address them through collaboration, educational programmes, and co-creation of tools, processes and guidance documents.

The Innovative Medicines Initiative funded-project <u>PARADIGM</u> is currently developing tools aiming to make patient engagement in medicines R&D easier for all. Supported by the <u>Association of Innovative Pharmaceutical Manufacturers</u> (AIPM), the <u>European Federation of Pharmaceutical Industries and Associations</u> (EFPIA) and the <u>European Patient Forum</u> (EPF), these stakeholders would like to bring the conversation to the Central and Eastern European region. Our aspiration is to spark interest in improving patient engagement practices across the region and to be the first of many events that specifically address this topic for the benefit of patients and healthcare systems.

The PARADIGM consortium recognized that for the tools to have a global impact, the insights coming form regions where the patient engagement landscape is less mature are very much needed. Therefore, PARADIGM will organise 3 parallel workshops online, aiming to provide the opportunity for participants to give feedback and shape the thinking about the patient engagement tools that PARADIGM is working on in order to support sustainable patient engagement across the board.

These workshops are to be held in the framework of the "From Gaps to Bridges: The Future of Patient Engagement in Central and Eastern Europe" conference that has been postponed due to the recent COVID-19 outbreak -initially planned for May 11-12<sup>th</sup>. The live conference is to be held at a later date, which will be communicated as the circumstances allow.

The workshops will focus on three topics. Expected outputs are specific amendments or recommendations to the IMI PARADIGM deliverables and the consolidated findings will be presented at the Patient Engagement Open Forum 2020:









# Workshop #1: The development of the roadmap to making the patient engagement ecosystem sustainable

- Identify CEE-relevant activities applicable to the identified intermediate goals

# Workshop #3: The development of the monitoring and evaluation framework to assess the value of patient engagement activities

- Stress test the current framework with sets of metrics to determine the value of patient engagement
- Enrich the co-developed framework with metrics that capture value from the CEE perspective

- Improve the meaningfulness and feasibility of the monitoring and evaluation framework for the CEE region
- Participants are supported in developing a coherent evaluation approach
